AIXM CCB, Washington DC February 21 – 23, 2018

Meeting notes and actions

- 1. ICAO Annex 15, PANS-AIM, DOC 8126
 - ICAO Annex 15 and PANS-AIM will not refer to AIXM. The new AIS Manual will probably refer to AIXM (to the web site or maybe to specific documents) as means of compliance.
- 2. Common practices discussion
 - a. In fact it concerns the separation of the information into domains what should be in IWXXM versus AIXM and even in FIXM? Discussion for IMP...
- 3. Discussion about data sets versus service as means of providing the digital data products specified in the new Annex 15 and PANS-AIM
 - a. Coding guidelines have been developed for 'data sets' as files (see
 https://ext.eurocontrol.int/aixm_confluence/display/ACGAIP/Interoperability+rules);
 - b. European States intend to provide 'data sets' as specified by ICAO, as a minimal service. For example, there will probably exist an AIP data set (as a file) for each European State, one Obstacle file for Area 1, one Obstacle file for each Airport Area 2, etc. Additional services (see what is available based on WFS, for example in EAD) might also be provided;
 - c. FAA intends to provide query/reply "services" at feature level, not complete data sets; Presentation on Friday will explain what is/will be available;
 - d. The ICAO AIM Project "SWIM Services" is expected to define a concept of services that would fill in the gap left by the PANS-AIM (where there is no specification of how the digital data sets are to be provided).
- 4. Route issues
 - a. All discussed

 - c. 11 either ready for CP or awaiting for clarifications
- 5. Obstacle issues

- 6. Airport issues
 - a. All discussed
- 7. 3D Geometries

- 8. Free routes
 - a. ICAO IFPP discusses free routes, no significant progress
 - b. Maybe raise it to the ICAO AIM Projects as a need to harmonise the data publication requirements associated with the introduction of Free Route Airspace?
